

Extract from the proceedings of the meeting of the Governing Body held on 10.08.2022 in the chamber of the Principal at 12.00 Noon

Item No. 07: It is resolved that the Festival Advance for the year 2022-23 be fixed at Rs 20,000/- (twenty thousand) for each willing full-time teaching staff, SACT and non-teaching staff. Festival advance for willing Boys' Hostel staff will be Rs 20,000/- (twenty thousand) per head; the amount will be Rs. 20,000/- (rupees twenty thousand) for each willing casual employee and the amount will be Rs. 8,000/- (rupees eighteen thousand) for each willing temporary casual employee and Samik Jash (Temporary Librarian, B.Ed.). The entire advance amount of temporary casual employee will be paid from Morning Section college fund but the advance amount of teaching staff, SACT, non-teaching staff, permanent Boys' Hostel staff, casual employee, Sunil Bairagya and Amar Das be paid from Day section fund. In each case, the advance will be realized from the salary/salary advance, as the case may be, in 08(eight) equal installments starting from November, 2022 from respective offices. Any willing employee who will retire within 8 months will be entitled to get the Festival Advance equal to the remaining months multiplied by Rs.2500/-. It is also resolved that ex-gratia amounting to Rs.4800/- each be paid to the casual non-teaching staff from Day section fund as per Government rules. It is further resolved that Rs.2500/- each be paid as ex-gratia (2021-22) to temporary casual employees of Boys' & Girls' Hostel, Samik Jash (Temporary Librarian, B.Ed.), temporary Group-C and Group-D staff including Rakesh Horizon, Bikash Harizan, Jahir Sk, Sanjoy Ganguli, Sunil Bairagya, Pratul Banerjee and Subrata Pal (pump operator) from Morning Section college fund.
