MEMORANDUM OF UNDERSTANDING (MOU)

BETWEEN

DASARATHI HAZRA MEMORIAL COLLEGE, BHATAR, PURBA BARDHAMAN AND KATWA COLLEGE, KATWA, PURBA BARDHAMAN

This Memorandum of Understanding (MOU) is made on 23.04.2024 between Dasarathi Hazra Memorial College and Katwa College. Dasarathi Hazra Memorial College was established in 2013 and affiliated to The University of Burdwan. The college is West Bengal Govt-aided, having its campus at Sotkhali, Bhatar, Purba Bardhaman, West Bengal. The college is represented by its Principal, Dr. Md. Inamur Rahaman, son of Late Shamsur Rahman, hereinafter referred to as the FIRST PARTY (Which term or expression shall unless excluded by or repugnant to the context be deemed to mean and include its successor in office, representatives, administrators and assigns) OF THE ONE PART.

On the other hand Katwa College, established in 1948 and affiliated to The University of Burdwan, having its campus at Katwa, Purba Bardhaman, represented by its Principal, Dr. Nirmalendu Sarkar, son of Late Rabindranath Sarkar, hereinafter referred to as the SECOND PARTY (Which term or expression shall unless excluded by or repugnant to the context be deemed to mean and its successor in office, representatives, administrators and assigns) OF THE OTHER PART.

Whereas, both Parties wish to collaborate and cooperate for the betterment of academic facilities, advancement of education, and other development related matters.





Now, therefore, in consideration of the premises and mutual promises contained herein, the First Party and the Second Party hereby agree as follows:

## **OBJECTIVES:**

The objectives of this MOU are:

- a) To promote academic excellence and innovation in education
- b) To facilitate the sharing of academic resources between the two institutions
- c) To collaborate in the development of new educational programmes and initiatives
- d) To share information and expertise in areas of mutual interest

### AREAS OF COOPERATION:

The First Party and the Second Party will cooperate in the following areas:

- a) Sharing of academic resources such as libraries, laboratories, and teaching materials
- b) Joint research projects and academic publications
- c) Exchange of faculty, staff, and students
- d) Joint academic conference and seminars
- e) Collaborative programme, development and delivery
- f) Collaboration in office work related matters

# IMPLEMENTATION:

To implement this MOU, the First party and the Second Party will:

- a) Appoint a liaison officer from each institution to facilitate communication and coordination
- b) Establish working committees to oversee and implement specific areas of cooperation
- c) Hold regular meeting to review progress and identify new areas of cooperation
- d) Collaborate on grant proposals and funding opportunities to support joint projects and initiatives

### **DURATION AND TERMINATION:**

This MOU will be effective for a period of 5 years from the date of signing. Either party may terminate this MOU upon written notice to the other party.

### MODIFICATIONS:

This MOU may be modified or amended at any time by mutual agreement of both parties in writing. In witness whereof, the parties have executed this MOU on the date and year first written. This MOU will be executed in duplicate, with each party receiving an original signed copy.
