Projects, which may be undergoing and/or have been undertaken, should be completed before termination of the agreement.

### **GOVERNING LAW AND DISPUTES**

The laws of India shall govern this agreement and any & all obligations arising out of or connected to it. Each Party submits to the exclusive jurisdiction of the courts in Kolkata. Any disputes with respect to any matter or thing arising out of or relating to the agreement shall be referred to a sole arbitrator to be appointed by mutual consent. The arbitration shall be conducted at Kolkata and the language of the arbitration proceedings shall be English.
